Returned Checks/Declined Transactions Trial Secretary will add a \$25 service charge for any returned check or declined credit card transaction. Subsequent returned checks from the same exhibitor may result in being placed on a CASH ONLY basis.

NOTE: Some GPSs will route you to the wrong location when using the Hwy 49 address. Use 4551 Old Airport Rd., Concord, NC 28025 and you won't have a problem! Safe travels!

From Charlotte, Kings Mountain & Gastonia (via I-85): Take I-85 North to Exit 48 (I-485). Turn right on I-485 East, travel to NC 49 (Harrisburg). Turn left on 49 North, through Harrisburg - cross under US 601 (Bridge) and follow NC 49 3.2 miles. Arena will be on the left. -Or: Take I-485 East to Exit 33 (Hwy. 49N - Harrisburg). Stay on Hwy. 49 N about 13.5 miles. Arena will be on the left.

From Albemarle: Take NC 73 West through Mt. Pleasant. Turn right on NC 49 South, travel 2.9 miles. Arena will be on the right. **From Asheboro:** Take NC 49 S, go under NC 73 (bridge). Go 2.9 miles. Arena is on the right.

From Davidson, Cornelius, Huntersville: Take NC 73 East to US 29/Hwy. 601. Turn right, travel 2.2 miles, stay left and follow US 601 to NC 49 North. At red light, turn left onto NC 49 North. Travel 3.2 miles. Arena will be on the left.

From Monroe: Take US 601 North to NC 49 North. Travel 3.2 miles and Arena will be on the left.

From Salisbury: Travel I-85 south take Exit 60. LEFT on Dale Earnhardt/Copperfield Blvd. Follow to NC 3 (about 1.5 miles). Turn left at the red light and follow NC 3 to US 601 (go through about 6 red lights). Turn left at red light onto NC 49 North and follow NC 49 3.2 miles. Arena will be on the left.
