

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. ***ALL checks received will be deposited and must clear to be considered a valid entry.*** **Electronic entry forms** will be accepted with payment by credit/debit card Your card statement will show a charge to *My Dogs Gym*

Returned Checks/Declined Transactions Trial Secretary will add a \$25 service charge for any returned check or declined credit card transaction. Subsequent returned checks from the same exhibitor may result in being placed on a CASH ONLY basis.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks and declined credit card transactions do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of such entries. ***ALL checks received will be deposited and must clear to be considered a valid entry.***

CLASS TRANSFERS

Transfers to move up must be received no later than 30 minutes after last run each day for the next day. **Transfers to move-up for Saturday event 2 will be accepted until Noon Saturday 8/13/22.**

Mailed transfers will be accepted until six pm on Monday August 8, 2022. Email transfers accepted until 6 pm Wednesday August 10, 2022

Transfers to correct errors in your entry(s) will be accepted no later than the 30 minutes before the scheduled start time each day.

Transfers must be in writing on Transfer forms available at Secretary's desk during the trial and online at www.mydoggym.com/events and www.AKC.org

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. **Dogs pulled after closing** because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee less a \$5 per trial processing fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of each trial. Refunds will be mailed after completion of the trial.

RIBBONS AND PRIZES

All prizes and ribbons must be claimed day of the show. None will be mailed or otherwise distributed.



Placement ribbons will be awarded in each class as follows:

<i>First Place</i>	<i>Blue Rosette</i>
<i>Second Place</i>	<i>Red Rosette</i>
<i>Third Place</i>	<i>Yellow Rosette</i>
<i>Fourth Place</i>	<i>White Rosette</i>
<i>Qualifying Score</i>	<i>Dark Green Ribbon</i>

High in Trial (HIT) Teams earning High in Trial in each level will receive a HIT rosette. Only teams who participate in all elements in the same difficulty level offered (Container and Buried), and qualify in each element, are eligible to win **High in Trial**. One HIT winner is chosen for **each level**; there is not a separate HIT for the Novice A and Novice B sections. The HIT is determined by adding each team's faults across the elements.

Ties If there is a tie based on faults for any award, then each team's times across the elements will be summed and the faster-finishing team wins.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Dogs with physical challenges Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge. (Chapter 2, Section 3 of the Scent Work Regulations).

CLASSIFICATIONS

Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers. **Novice B Classes** are open to all dogs.

Advanced Classes are open to dogs who have achieved the Novice title for that element. **Excellent Classes** are open to dogs who have achieved the Advanced title for that element. **Master Classes** are open to dogs that have achieved the Excellent title for that element. **Detective class** is open to dogs who have achieved a Master title in any Odor Element.

Handler Discrimination classes are titling classes in which the targeted scent is that of the handlers themselves. Not offered at this event.

Dogs may enter up to **two (2) difficulty levels in each element**, in each trial. Dogs may only enter a class once in each event. A class is defined as a particular difficulty level within a particular element, *For example, a dog may run in both Novice B and Advanced Interior in the same trial, but may not run in Novice A and Novice B Interior in the same trial.* **Dogs may only enter classes** for which they are eligible according to the above guidelines. Dogs that have previously earned the same or higher level AKC Scent Work titles may also enter lower level classes.

SEARCH AREA AND RING CONDITIONS

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces. This facility is ADA accessible throughout.

Search Area Sizes Refer to the Scentwork Regulations for search area sizes and other requirements. Search areas may be of any shape and of the size specified in the Regulations for each class.

Exhibitors MUST check-in for each trial in which they are entered. *Time listed are approximate and may change after entries close or on the day of trial. Check schedule included with your entry confirmation to be sure.*

SCENT WORK STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area and search areas will be in climate controlled building including check-in, warm-up and waiting area, as well as the secretary table for posting of running order, results, and ribbons. Public restrooms will also be in this area. **Crating space** will be available on first come first claimed basis; gear may be left inside overnight. Crates okay but No ex-pens. *Reactive or noisy dogs may be asked to stage from their vehicles.*

Dog exercise Area –Dogs must remain on leash at all times and handlers must practice social distance of at least 6 feet between humans. **Exhibitors are responsible for cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the grounds.

A **Handlers Briefing** will be conducted onsite by the judge as you enter the search area. There will be a group briefing prior to the start of each day's judging and may include a walkthrough of the area.

Warm-up Area One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. The warm-up area is not for training or relieving of the dog. (Chapter 5, Section 34 of the Scent Work Regulations).

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. (Chapter 3, Section 15 of the Scent Work Regulations).

Possession of Odors and Training. Chapter 5, Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

These trials will be held indoors, air conditioned indoor location. There is plenty of room for crating and lots of grassy areas for walking dogs. There will be a \$7 per day parking fee. Please adhere to the following rules while at the site:

- Please be considerate of others and conserve crating space. Stack crates whenever possible and leave aisle ways clear or we will have to move you.
- ALL crates must be zipped when occupied by a dog.
- Please be considerate of the team in the ring when walking along the ringside aisle way.
- No smoking within 30' of the building.
- Please do NOT walk your dogs in any area that has been mulched or landscaped to include gardens, flower beds or shrubs.
- Do not allow your dogs to relieve themselves on trashcans and/or the building.
- Flexi-Leads MUST be kept at the 2' LOCKED position when used IN and NEAR the building.
- X-Pens are NOT allowed in the arena.
- No baby strollers in or around the rings.
- Children who are not entered in this event cannot be on the exhibition floor and must be attended at all times.
- Please pick up your trash and either pack it home or leave in one of the many trash cans on site. It could be your dog that eats a bottle cap or piece of foil.
- **CLEAN UP AFTER YOUR DOGS and YOURSELVES!!!** Pooper scoopers and trash bags will available for clean-up.
- Please be considerate of others. We would like to be invited back!
- All Violations will be referred to the Event Committee for a hearing.



DIRECTIONS TO THE EVENT SITE

NOTE: Some GPS will route you to the wrong location when using the Hwy 49 address. Use 4551 Old Airport Rd., Concord, NC 28025 and you won't have a problem! Safe travels!

From Charlotte, Kings Mountain & Gastonia (via I-85): Take I-85 North to Exit 48 (I-485). Turn right on I-485 East, travel to NC 49 (Harrisburg). Turn left on 49 North, through Harrisburg - cross under US 601 (Bridge) and follow NC 49 3.2 miles. Arena will be on the left. -Or: Take I-485 East to Exit 33 (Hwy. 49N – Harrisburg). Stay on Hwy. 49 N about 13.5 miles. Arena will be on the left.

From Albemarle: Take NC 73 West through Mt. Pleasant. Turn right on NC 49 South, travel 2.9 miles. Arena will be on the right. **From Asheboro:** Take NC 49 S, go under NC 73 (bridge). Go 2.9 miles. Arena is on the right.

From Davidson, Cornelius, Huntersville: Take NC 73 East to US 29/Hwy. 601. Turn right, travel 2.2 miles, stay left and follow US 601 to NC 49 North. At red light, turn left onto NC 49 North. Travel 3.2 miles. Arena will be on the left.

From Monroe: Take US 601 North to NC 49 North. Travel 3.2 miles and Arena will be on the left.

From Salisbury: Travel I-85 south take Exit 60. LEFT on Dale Earnhardt/Copperfield Blvd. Follow to NC 3 (about 1.5 miles). Turn left at the red light and follow NC 3 to US 601 (go through about 6 red lights). Turn left at red light onto NC 49 North and follow NC 49 3.2 miles. Arena will be on the left.

From Columbia, South Carolina: Take I-77 North to I-485 East to Exit 33 (Hwy. 49 North – Harrisburg). Stay on Hwy. 49 North for approximately 13.5 miles. Arena will be on the left.

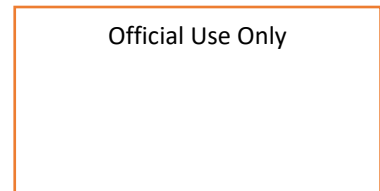
