## ENTRY INFORMATION

**CLOSING:** Entries must be received by **Noon on Wednesday, March 18, 2026** at <https://greatermonroekc.org> events or by USPS at the home of the Rally Trial Secretary; after which, entries cannot be accepted, cancelled, substituted or revised as noted in Chapter 11, Section 6 of the AKC Show/Trial Manual.

**WAITLIST:** A waitlist will be kept for these trials. If entries are withdrawn prior to the closing date, these slots will be filled from the waitlist. Refunds of registration fees will be given after **12 pm on Wednesday, March 18, 2026.**

**ACCEPTANCE:** Entries will be accepted in the order received; until the judging time limit, entry limit or closing date and time is reached.

**NON-ACCEPTANCE:** Entries will not be accepted by email, telephone, or hand delivered.

**REFUND POLICY:** No entries may be withdrawn with a refund after closing **at 12:00 pm on March 18, 2026.** Females in season will be refunded the full entry fee less a \$5 per run entry fee. Notification in writing or email must be given to the Trial Secretary no later than one half hour prior to the start of the first class of the day of the trial. Dogs withdrawn after closing because of injury or other medical condition (including Canine Influenza) are not eligible for a refund.

**NO REFUNDS WILL BE GIVEN FOR:**

- Cancellation, substitution or correction of entry after the closing date.
- If a dog is absent, disqualified, excused by the judge.
- If a dog is barred from competition by action of the Show Committee.
- If it is impossible to open or complete the show because of weather, riots, civil disturbances or other acts, beyond the control of Greater Monroe Kennel Club.

**ACKNOWLEDGMENT:** Entries will be acknowledged as soon as practical. If you have not received an acknowledgment one week after closing, please notify the Rally Trial Secretary at [gmkcrallyts@gmail.com](mailto:gmkcrallyts@gmail.com)

**TRANSFERS:** The rally trials will allow transfers in accordance with AKC's obedience and rally rules. Transfers will only be permitted provided the class is available and the maximum number of dogs per day for that judge has not been reached. The deadline for transfers is no later than **30 minutes prior to the start of the entire trial** for which the transfer is being requested. (For example, if the trial starts at 8 a.m., no transfers can be submitted after 7:30 a.m.)

When possible, exhibitors are strongly encouraged to submit transfer information to the Trial Secretary before the day of the trial:

- Transfer forms will be available at check-in table.
- Those wishing to make a transfer for the first day they are entered in the trial weekend should email their transfer request to the Trial Secretary by 12:00 pm on Wednesday, March 18, 2026.
- Day-to-day transfers should be submitted in-person to the Trial Secretary before leaving that day's event. (For example, if you finish a title on Saturday, Trial 2 and wish to move up for Sunday, Trial 1 you should submit your transfer before leaving Saturday's Trial 2.)

### GENERAL INFORMATION

**LIABILITY:** Greater Monroe Kennel Club will not be held responsible for damage, injury or loss of property either in the building or on the grounds. Children are the responsibility of their parents and must be under control at all times. Waiver of Rights for Animals in Distress: The Winston Salem Dog Training Club reserves the right to remove any animal in distress from a parked vehicle or crate and all persons attending this dog show hereby waive any claim for damages against the club for such removal.

**JUDGING:** Judges will not wait for any handler holding up a class. Owners and Agents alone are responsible for the presence of their dogs in the ring when their classes are called to be judged. Consult the judging program and Check-in at least 15 minutes before your class. Handlers should notify the table steward of any judging conflict and must accept the judge's decision, whether or not to revise the judging order.

**DOGS:** Only dogs entered in the trial are allowed in the building. Unless being judged, dogs are not allowed in the rings. Dogs are not allowed in the building overnight. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Signs will be posted stating where you may walk your dog. Our neighbors have asked that dogs not eliminate on their grass. Violators of these conditions will be asked to leave the trial.

Only dogs entered in the trials are allowed inside the GMKC building.

**DISRUPTIONS:** Dogs that are causing a disruption while crated inside the building will be asked to leave the building and crate in the exhibitor's car.

**CRATING:** Dogs will be permitted to be crated inside the building; however, dogs will not be allowed to be with their handlers on leash uncrated inside the building unless they are (1) entering or leaving the building, (2) are in the warmup ring, (3) are on deck to go into the ring. All dogs must remain crated in designated areas or outside in the exhibitor's vehicles. This procedure is being implemented to ensure the safety of our handlers, their dogs, and our spectators. We thank you for your understanding and cooperation.

**FOOD:** No food will be available for exhibitors on Friday or Saturday. Bring your own lunch, snacks, and drinks.

## AKC CODE OF SPORTSMANSHIP

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

**AGREEMENT**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. **INSTRUCTIONS**

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
